

The Rush County Council met for a Special Council meeting on Tuesday, November 20, 2018 at 8:00 a.m. with County Council Members Gerald Mohr, Charles Smith, Janet Kile, Warren Norris, Marvin Hedrick, Scott Barnes, and Steve McCorkle, Jodi Harr, Auditor and County Attorney Leigh Morning in attendance.

Council Chairman Gerald Mohr called the meeting to order at 8:00 a.m.

Highway Superintendent Jerry Sitton presented two letters to the Indiana Department of Transportation for the council to approve Chairman Gerald Mohr to sign. Both letters are letters stating the Rush County Commissioners and the Rush County Council irrevocably commit to pay the Rush County share of the federal aid projects costs, if such projects are approved for funding, for the replacement of the Bridge # 1 1100 North over Six Mile Creek and Bridge #155 450 South over Branch Little Flatrock River. Marvin Hedrick made the motion for Mohr to sign the financial commitment letter for Bridge #1. Janet Kile seconded. Motion carried. Charles Smith made the motion for Mohr to sign the financial commitment letter for Bridge #155. Steve McCorkle seconded. Motion carried.

1782 NOTICE FOR 2019 BUDGET

Auditor Jodi Harr presented the 1782 Notice for the 2019 Rush County Budget. The Indiana Department of Local Government Finance is recommending cuts to the County General, Health and Reassessment funds prior to the Final 2019 Budget Order being issued.

Marvin Hedrick made the motion for an Appropriation Reduction Ordinance in the amount of \$4,277.00 be approved in Fund 1159 Health for budget year 2018 expenditures. Steve McCorkle seconded. Motion carried.

Charles Smith made the motion for an Appropriation Reduction Ordinance in the amount of \$145,640.00 be approved in Fund 1000 County General for budget year 2018 expenditures. Steve McCorkle seconded. Motion carried.

Janet Kile made the motion for an Appropriation Reduction Ordinance in the amount of \$20,401.00 be approved in Fund 1188 2015 Reassessment for budget year 2018 expenditures. Scott Barnes seconded. Motion carried. There will be an additional \$63,966.00 that will need to be cut from 2019 Reassessment Fund expenditures. County General or Rainy Day funds will need to be used for any expenses not financed in the approved Reassessment budget.

Steve McCorkle moved to adjourn the county council meeting. Warren Norris seconded the motion. Motion carried
