RESOLUTION #___ RESOLUTION MODIFYING LOCAL INCOME TAX RATES FOR RUSH COUNTY

BE IT RESOLVED by the County Council of Rush County, Indiana, that that a need now exists to modify the local income tax rates imposed in the following way [Note this will not result in a change to the tax rate, it will result in the following allocation changes]:

ALLOCATION OF PUBLIC SAFETY TO TOWNSHIP FIRE DEPARTMENTS VOLUNTEER FIRE DEPARTMENTS, FIRE PROTECTION TERRITORIES, OR FIRE PROTECTION DISTRICTS UNDER IC 6-3.6-6-8(d)

From the LIT amount generated by the Public Safety Rate (IC 6-3.6-6), the following qualifying service providers shall receive a specified amount of the tax revenue to be distributed under this section during the following calendar year.

The above allocations are maximum amounts. If after the allocation to the PSAP (as previously established), funds are insufficient to cover 100% of the above amount, the amount to Clarksburg Community VFD shall remain at \$2,000 and all other amounts shall be reduced pro rata so that the full amount of the actual revenue received is used.

BE IT FURTHER RESOLVED that a public hearing was held on the proposed local income tax rate modifications on August 20, 2025. Proper notice of the public hearing was provided pursuant to IC 5-3-1.
