The Rush County Board of Commissioners met in regular session Monday, July 6, 2021 with Commissioners, Mark Bacon, Paul Wilkinson and Ron Jarman present. Auditor Tammy Justice and County Attorney Leigh Morning was also present.

Mark Bacon called the meeting to order at 9:00 a.m. with the Pledge to the American Flag.

MINUTES

• Minutes of the Regular Session held on June 21, 2021 were presented. Ron Jarman made the motion to approve. Paul Wilkinson seconded. All were in favor. Motion carried.

CLAIMS

• Accounts Payable claims for July 6, 2021, in the amount of \$596,897.50 were presented. Paul Wilkinson made the motion to approve the claims. Ron Jarman seconded. All were in favor. Motion carried.

PAYROLL

 Payroll for July 9, 2021, in the amount of \$200,449.40 was approved on a motion by Ron Jarman. Seconded by Paul Wilkinson. All were in favor. Motion carried.

SENIOR CENTER

- Sande Land was present and gave an update on the 2022 Ride Rush grant. On July 7. 2021 Tina Logan will be meeting via zoom with Todd Jennings with the updated revisions on the 2022 budget that was presented in May. As soon as the revisions are corrected and approved by INDOT Tina will notify the Commissioners, Leigh Morning, Auditor and Board Members.

- Sheriff, Allan Rice discussed the final date for Deputy Schultz. Deputy Schultz will be going to Greenfield Police Department and his first day is August 9, 2021 but Sheriff Rice has not received a letter of resignation from Deputy Schultz. Sheriff Rice also indicated maybe in the near future look at increasing the wages for the deputies.
- Sheriff also indicated that there have been 19 accidents in the last 2 weeks and the fair went good and they were able to cover every night.
