## **MINUTES**

- Minutes of the Regular Session held on May 10, 2021 were presented. Paul Wilkinson made the motion to approve. Ron Jarman seconded. All were in favor. Motion carried.
- Minutes of the Special Session Minutes on May 14, 2021 were presented. Paul Wilkinson made the motion to approve. Ron Jarman seconded. All were in favor. Motion carried.

# **CLAIMS**

### Area Plan

Greg Duke discussed a Rezone of 1203 W Old State Rd 44 which has a

Paul Wilkinson made a motion to approve the Repairs for the padding for June 7, 2021, with Marathon Engineering Corporation. Seconded by Ron Jarman. All were in favor. Motion carried.
- Discussion was held on Hot Water in Cell D & E. They had Choice look at it. There is a quote for \$3,365.00 to install the 2<sup>nd</sup> circulation pump from Choice. Commissioner Paul Wilkinson indicated before we spend the money we would need to have a warranty statement to make sure this will fix the problem. Continue discussion on Hot Water issues.
- Megan contacted Choice on the softener. There is an increase in the pricing of materials. Sheriff Allan Rice indicated we really need a micron filter. Continue discussions on the softener and micron filter. Megan will get a quote from QPH.
- Discussion was held on mowing the areas of the Courthouse parking lot and around the Jail. Paul Wilkinson made a motion for Singelton's to mow the Courthouse parking Lot and Jail for 50.00 per service. Seconded by Ron Jarman. All were in favor. Motion carried.
- Megan also gave a update on the Roof on the Jail.

Seconded by Ron Jarman. All were in favor. Motion carried.
- Tony indicated we have a new part time jailor, Isaac Chastain. Paul Wilkinson made a motion to approve to hire Isaac Chastain. Seconded by Ron Jarman. All were in favor. Motion carried.
- Tony indicated also that they having difficulty in hiring for the full time Jailor and a full time Dispatcher. Discussion was held.
- Tony indicated the prosecutor will be hiring for temporary part time for the summer. Paul Wilkinson made a motion to approve hire Trisha Mastin.
   Seconded by Ron Jarman. All were in favor. Motion carried.
- There will be a mandatory meeting on Jun 25, 2021, dealing with Audit American and also dealing with difficult patrons. There also needs to be protocols or emergency procedures to respond during and after issues that may come up. Ron Jarman made the motion to have an Executive Meeting on May 27, 2021, at 8:00 a.m. to discuss Security. Seconded by Paul Wilkinson. All were in favor. Motion carried.

### **HIGHWAY**

- Discussion was held on a Federal Agreement to house federal inmates. Ron Jaman indicated this is an opportunity to make income. Most of the housing inmates would be here for pre-trial. Continue discussion. The study would cost us \$28,500.00. The commissioners will continue this to the next regular commissioners meeting. The Sheriff and Auditor will look at where to fund the study.
