We are running a minimal staff in the jail. Discussion was held of how many that are leaving because of salaries. Sheriff Rice indicated his last deputy left because of salary. Gregg Guerrettaz commented one of things they see are average age of the jail are considerably less. Sheriff Rice indicated at the end of 2 years you receive \$2,000.00 and 4 years you receive \$4,000.00 longevity. We are going below the age of 21 to hire in the jail. Continue discussions.

- Discussion was held on shorter shifts of jail and 16 correction officers with 4 correction officers per crew.
