**FINAL ORDER IN GARNISHMENT**

This matter is submitted upon Plaintiff's Motion to Enforce Judgment by Proceedings Supplemental.

The Court finds that the allegations of Plaintiff's petition are true; Plaintiff is the owner of an unpaid judgment against the Judgment Defendant, \_\_\_\_\_; and is entitled to recover from the earnings of the Judgment Defendant, an amount required to satisfy said judgment, costs and interest.

The Court further finds the Garnishee Defendant pursuant to I.C. 24-4.5-5-105, is entitled to a fee for processing this order, of the greater amount of twelve dollars (\$12.00) or 3%.

IT IS THEREFORE ORDERED that \_\_\_\_\_, as Garnishee defendant, pay into the court at least monthly, the lessor of one of the following amounts:

- (1) 25% of the Judgment Defendant's disposable earnings; or
- (2) The amount by which the Judgment Defendant's disposable earnings exceed thirty (30) times the federal minimum hourly wage (\$5.85 per hour x 30 = \$175.50) in effect at the time the earnings are payable.

Disposable earnings are those amounts remaining after deducting, ONLY, the following from gross earnings:

(a) Federal Income Tax, (b) Federal Social Security, (c) Indiana Adjusted Gross Income Tax  
To be applied upon the judgment rendered in this cause, upon which there is an unpaid balance, including costs, of \$ \_\_\_\_\_, until unpaid balance is fully paid and satisfied.
