WM. GLENDENNING TILE

Mr. Justin Orme spoke asking if the Board would move this drain to the top of long-range plan. Surveyor than suggested that we make this is a partial reconstruction. Surveyor than stated we pro long this to late 2023 or 2024. Motion was made by Jarman, 2nd by Wilkinson. Motion Carried.

Justin Orme than stated to the Board his concern of the Perry Davis Drain they are having to fix 3 to 6 blowholes and it is a safety concern. Surveyor than stated it is on the list for 2025 Reconstruction.

LUCINDA HARCOURT TILE

Mr. Mahan stated wants to start a Major Maintenance project on this drain. Surveyor stated in 2013 the lower end was replaced with a 24" tile. He then recommended raising the drain to \$25 an acre. Motion to have a hearing to raise assessments set for February 13th, 2023. Motion made by Jarman, 2nd by Wilkinson. Motion carried.

RUSH COUNTY STORM DRAINAGE ORIDANCE

Surveyor stated Duke Energy sent an email stating they want to put a new sub station in Glenwood. Surveyor showed the Board the drainage plan that was sent to him. They said that the \$75.00 check was in the mail. Motion by Jarman to accept the plan and send them this notice once the check arrives. 2nd by Wilkinson. Motion carried.
