MINUTES

EMA

• EMA Director Chuck Kemker presented his annual time card for the Commissioners approval. This approval is needed for grant reimbursement of his wages. Ron Jarman moved to sign Director Kemker's annual time card. Seconded by Kenny Aulbach. All were in favor. Motion carried.

JAIL

• Matron Megan Tate inquired about the status of the preventative maintenance bids. She was advised the Commissioners are still working on getting that done.

• Matron Megan Tate informed the Commissioners of clogged air vents at the jail.

HIGHWAY

- Superintendent Jerry Sitton presented the Commissioners with the Highway's February monthly report.
- Superintendent Jerry Sitton extended his appreciation to the Commissioners for their part in increasing wages for county employees.

SHERIFF

- Sheriff Allan Rice advised the Commissioners the jail is currently housing 60 inmates.
- Sheriff Allan Rice extended his appreciation to the Commissioners for their part in increasing wages for county employees.
- Sheriff Allan Rice advised the Commissioners there are no updates as of yet on the in-custody death of an inmate.
- Sheriff Allan Rice advised the Commissioners that one of the Durango's in his fleet, came in contact with high water which caused the engine to blow up.
- Sheriff Allan Rice advised the Commissioners he has been officially approached, by Davis Towing, regarding the return of a trailer the department is using of theirs. The trailer, which was obtained by the previous administration, is housed at the Highway Department and used to store evidence and records. Sheriff Rice was not given a timeframe of when the trailer needs returned. Sheriff Rice is looking at possibly putting fencing up in the air handler room, at the jail, in order to securely store the evidence and records from the trailer.

MISC

- Sande Land, for the Senior Citizens Center, presented the Commissioners with a Motor Vehicle Purchase Agreement for Ride Rush for their approval. This is for the purchase of a low floor minivan with center seat in the amount of \$68,967.00. Local share amount of \$13,793.40 will be paid from funds at the Senior Citizens Center.  balance owed until they receive an invoice and signed quote. Kenny
 Aulbach motioned to accept and sign the quote by Henry C. Smither
 Roofing Co. Inc. Seconded by Ron Jarman. All were in favor. Motion
