PROSECUTOR

• Prosecutor Phil Caviness requested approval from the Council to apply for the 2023-2024 STOP Grant in the amount of \$41,021.08 with a county match of \$13,673.69 which is paid out of Pre-Trial Diversion Funds. Kyle Gardner moved to apply for the 2023-2024 STOP Grant in the amount of \$41,021.08. Seconded by Denny Corn. All were in favor. Motion carried.

• IT Director Randy Herbert requested approval from the Council to advertise for an additional appropriation in the amount of \$50,000.00 for rising costs of maintenance. Amy Grocox moved to approve the updated 2023 Salary Ordinance. Seconded by Janet Kile. All were in favor. Motion carried.
- Auditor Tammy Justice advised the Council that Greg Guerrettaz with FSG would like to meet with the council and all officeholders from 9 am to 4 pm on August 29, 2023, to discuss budgets. The Council instructed Auditor Tammy Justice to reschedule their August 9, 2023, regular meeting to August 29, 2023.

- Sheriff Allan Rice presented the Council with the annual inmate trust and commissary reports.
- Sheriff Allan Rice presented the Council with a packet on the proposed matrix he used for the 2024 budgets.
- Sheriff Allan Rice advised the Council that Grant County has reached out for housing of their inmates. Proposed amounts for inmate housing will be given to the Grant County Council for their approval. Discussion was also held regarding housing of federal inmates.
- Sheriff Allan Rice advised the Council of staffing issues with the termination of a jailer. Hiring of a communications deputy that will need training and hiring of a matron and administrative secretary.

MISC

- Commissioner Ron Jarman updated the Council on the bid that was received to tear down the Moscow and Milroy properties.
- Commissioner Ron Jarman updated the Council on the status of the Community Center and Broadband.
