- Coroner Brenda McMahan advised the Council that the price of autopsies was increasing to \$2,200.00 each. McMahan was originally going to request a transfer of \$3,000.00 from 1000.40052.00000.0068 Council Use Only to 1000.30047.00000.0068 Autopsies but would like to increase that amount to \$4,000.00. Motion to change the amount from \$3,000.00 to \$4,000.00 was made by Scott Barnes. Seconded by Janet Kile. All were in favor. Motion carried.
- Coroner Brenda McMahan requested approval from the Council to transfer \$4,000.00 from 1000.40052.00000.0068 Council Use Only to 1000.30047.00000.0068 Autopsies. Amy Grocox moved to approve transfer. Seconded by Scott Barnes. All were in favor. Motion carried.

- Auditor Tammy Justice requested a recommendation from the Council regarding the 2024 Estimated Max Levy Report and the 2024 Estimated Property Tax Cap Impact Report. Carl Harcourt moved to make no recommendation. Seconded by Denny Corn. All were in favor. Motion carried.
- Auditor Tammy Justice requested instruction from the Council on where to put the Riverboat Revenue for 2024. Carl Harcourt moved to put the 2024 Riverboat Revenue in the Riverboat Fund. Seconded by Amy Grocox. All were in favor. Motion carried.
- Auditor Tammy Justice informed the Council that the maximum levy growth quotient for 2024 and 2025 is 4%.

- Sheriff Allan Rice advised the Council of an unruly inmate who ripped the sprinkler out of the ceiling in the padded cell. Damage to the padded cell is being assessed and repairs will begin.
