# **REGULAR SESSION RUSH COUNTY BOARD OF COMMISSIONERS December 4, 2023**

The Rush County Board of Commissioners met in regular session Monday, December 4, 2023, with Commissioners Mark Bacon, Ron Jarman, and Kenny Aulbach present. Auditor Tammy Justice was also present. County Attorney Leigh Morning arrived late.

Mark Bacon called the meeting to order at 9:00 a.m. with the Pledge to the American Flag.

#### **MINUTES**

• Minutes of the Regular Session held on November 17, 2023, were presented. Kenny Aulbach made the motion to approve the minutes. Ron Jarman seconded. All were in favor. Motion carried.

#### **CLAIMS**

• Accounts Payable claims for December 4, 2023, in the amount of \$2,259,955.30 were presented. This includes \$121,400.00 for the courthouse roof bond payment, \$609,000.00 for the jail bond payment and \$1,375,000.00 to the Community Foundation for the Rec. Center. Ron Jarman made a motion to approve the claims. Seconded by Kenny Aulbach. All were in favor. Motion carried.

## **PAYROL**L

• Payroll for December 8, 2023, in the amount of \$236,288.50 was presented. Ron Jarman moved to approve the payroll claims. Seconded by Kenny Aulbach. All were in favor. Motion carried.

### **HUMAN RESOURCES**

#### **MISC**

- Josh Estelle with McGowan Insurance updated the Commissioners regarding several companies willing to give favorable quotes. Estelle advised that the sexual abuse coverage application will need to be filled out and questions answered to get the proposals. HR Director Tony Personett advised the Commissioners he recommends signing off on the sexual abuse portion of the application. Ron Jarman moved to sign the sexual abuse application. Seconded by Kenny Aulbach. All were in favor. Motion carried.
- Jessica Roberts with Purdue Extension advised the Commissioners about an ag seminar at the Root Building. Roberts also advised the Commissioners the Extension Office and Rush Co Clerk are putting on a program January 11, 2024, for anyone interested in running for office.
- Steve Cain with Raleigh Fire & Ambulance advised the Commissioners they are willing to extend their contract for six (6) months.
- Commissioner Kenny Aulbach advised the Commissioners that Anderson Township Volunteer Fire and Ambulance are also willing to extend their contract for six (6) months.
- Kirk Trebley with the Rush County Fair Board updated the Commissioners regarding building a 40x60 barn dominium type building for the Extension Office that would include four (4) offices, secretary space and one (1) meeting room. Payment would be \$4,500.00 per month for a ten-year lease with the Commissioners supplying utilities, janitorial services, and insurance. Commissioner Mark Bacon stated he would like to see some other options. Commissioner Ron Jarman stated he would like to see possibly coming up with more upfront funds to get away from the high monthly lease payment.
- John Painter with CSI updated the Commissioners on the second inspection of the jail roof. Painter stated there was a caulking membrane that will be resealed. Painter also stated there is no reason a twenty (20) year warranty can't be issued with a two (2) year workmanship warranty issued by Horning. Painter advised the double fold of the roof seams will be scheduled for completion sometime around the second week of December 2023, at no cost to the County.
- IT Director Randy Herbert advised the Commissioners that Microsoft will be requiring multi-factor authentication for all county employees who login to email. Herbert currently was able to override the authentication for thirty (30) days. Commissioner Ron Jarman stated he would research this and come up with a solution.
- Commissioner Ron Jarman advised the Commissioners the first meeting for the comprehensive plan was held and more information will be going out to the public.
- Melissa Meltzer asked the Commissioners for an update on the Senior Center. Commissioner Kenny Aulbach stated he wanted to address a concern that there were missing funds, which is not the case.

Ron Jarman made a motion to adjourn. Seconded by Kenny Aulbach. All were in favor. Motion carried.
