All appeals shall be in writing addressed to the Department of Local Government Finance naming specifically the items in the budgets and the tax rates, which are objected to, and shall be filed with the County Auditor. The auditor shall forward the statement, with the budget to the Department of Local Government Finance for consideration. This notice is given in compliance with Acts of 1937, Chapter 119, as amended by Acts of 1947, Chapter 41, and the rights of taxpayers and manner of filing objections are set forth herein.
