

## **REGULAR SESSION RUSH COUNTY BOARD OF COMMISSIONERS April 21, 2025**

The Rush County Board of Commissioners met in regular session Monday, April 21, 2025, with Commissioners Ron Jarman, Jeff Wilson, and Kenny Aulbach were present. County Attorney Grant Reeves and Auditor Tammy Justice were also present.

Ron Jarman called the meeting to order at 9:00 a.m. with the Pledge to the American Flag.

### **MINUTES**

- Minutes of the Joint Session Rush County Council and Commissioner held on March 12, 2025, were presented. Jeff Wilson moved to approve the minutes as presented. Seconded by Kenny Aulbach. All were in favor. Motion carried.
- Minutes of the Regular Session Commissioner on April 7, 2025, were presented. Jeff Wilson moved to approve the minutes as presented. Seconded by Kenny Aulbach. All were in favor. Motion carried.

### **CLAIMS**

- Accounts Payable claims for April 21, 2025, in the amount of \$177,201.72 were presented. Jeff Wilson made a motion to approve the claims. Seconded by Kenny Aulbach. All were in favor. Motion carried.

### **PAYROLL**

- Payroll for April 25, 2025, in the amount of \$261,260.56, was presented. Kenny Aulbach moved to approve the payroll claims. Seconded by Jeff Wilson. All were in favor. Motion carried.

### **VACATED ALLEY**

- Dylan Legere asked the Commissioners to vacate an alley in the town of Milroy. Kenny Aulbach moved to set a public hearing for the vacation of the alley for May 19, 2025, at 9:30 a.m. Seconded by Jeff Wilson. All were in favor. Motion carried.

### **AUDITOR**

- Auditor Tammy Justice presented the Commissioners with a Class Agreement with Walgreens. The class action settlement agreed to a proposed settlement of One Hundred Billion dollar to settle allegation that Walgreens inflated it usual and customary prices and caused Class Member to overpay for specific prescription drugs. The County received notice on April 7, 2025. The County needed to act on the agreement by April 14, 2025. Commissioner Ron Jarman signed the True Scripts Class Action Service Agreement on April 9, 2025. Kenny Aulbach made a motion to approve and sign the True Scripts Class Action Service Agreement. Seconded by Jeff Wilson. All were in favor. Motion carried.

### **HEALTH**

- Dan Burklow indicated that the State has adopted a Food Code Order. The Health Department will be working on one for Rush County.

**HIGHWAY**

- Highway Superintendent Jerry Sitton informed the Commissioners they are working on Bridge 94.

**MISC**

- Rush County Attorney Grant Reeves presented the Commissioners Resolution Authorizing Joint Purchasing and a Resolution to Establish a Purchasing Policy. Attorney Reeves indicated that the Resolutions would help streamline purchasing for the county. Jeff Wilson made a motion to approve the Resolution Authorizing Joint Purchasing. Seconded by Kenny Aulbach. All were in favor. Motion carried. Kenny Aulbach made a motion to approve the Resolution to Establish a purchasing Policy for Rush County, Indiana. Seconded by Jeff Wilson. All were in favor. Motion carried.
