REGULAR SESSION RUSH COUNTY BOARD OF COMMISSIONERS August 11, 2025

The Rush County Board of Commissioners met in regular session Monday, August 11, 2025, with Commissioners Ron Jarman, Jeff Wilson and Kenny Aulbach present. Auditor Tammy Justice and County Attorney Grant Reeves were also present.

Ron Jarman called the meeting to order at 9:00 a.m. with the Pledge to the American Flag.

MINUTES

• Minutes of the Regular Session held on July 28, 2025, were presented. Kenny Aulbach made a motion to approve the minutes as presented. Second, by Ron Jarman. All were in favor. Motion carried.

CLAIMS

• Accounts payable claims for August 11, 2025, in the amount of \$365,008.63 were presented. Jeff Wilson made a motion to approve the claims. Second, by Kenny Aulbach. All were in favor. Motion carried.

PAYROLL

• Payroll for August 15, 2025, in the amount of \$262,353.94, was presented. Jeff Wilson moved to approve the payroll claims. Second, by Kenny Aulbach. All were in favor. Motion carried.

SENIOR CENTER

• Director Angela Cavaletto requested approval from the Commissioners on the 2nd quarter Section 5311 Rural Transportation Grant reimbursement. Jeff Wilson moved to approve the 2nd quarter reports. Second, by Kenny Aulbach. All were in favor. Motion carried.

HUMAN RESOURCES
