

## **REGULAR SESSION RUSH COUNTY BOARD OF COMMISSIONERS**

### **January 26, 2026**

The Rush County Board of Commissioners met in regular session Monday, January 26, 2026, with Commissioners Ron Jarman, Jeff Wilson and Kenny Aulbach present. Auditor Tammy Justice was also present. County Attorney Grant Reeves was not present.

Ron Jarman called the meeting to order at 9:00 a.m. with the Pledge to the American Flag.

### **MINUTES**

- Jeff Wilson moved to sign the Local Disaster Emergency Declaration for dangerous weather conditions beginning on Saturday, January 24, 2026, at 12:00 p.m. and lasting through Monday, January 25, 2026, at 1:00 p.m. Second, by Kenny Aulbach. All were in favor. Motion carried.
- Director Chuck Kemker updated the Commissioners on the weather conditions as well as the road conditions.

### **HIGHWAY**

- Superintendent Jerry Sitton requested approval of the Commissioners for the CCMG paving contract with Dave O'Mara in the amount of \$444,775.65 where INDOT will pay 80%. Kenny Aulbach moved to sign the agreement with Dave O'Mara. Second, by Jeff Wilson. All were in favor. Motion carried.
